

TOWN OF LOGANSPOUR  
MINUTES  
September 10, 2013

The regular meeting of the Logansport Town Council was held Tuesday, September 10, 2013 at 6:00 p.m. in the Council Chamber with Mayor Katherine Freeman presiding. Council members present: Norman Arbuckle, Judge Cordray, Martha Guillotte, Dale Morvan, and Edith Williams. Four guests were in attendance.

The meeting opened with the Lord's Prayer and the Pledge of Allegiance.

With a motion from Mrs. Williams and second from Mr. Arbuckle a public hearing was opened for comments on Ordinance #690—An ordinance to abandon Jack Drive, a dedicated, but unopened street within the corporate limits of the Town of Logansport. It was explained the property would revert back to the property owner upon adoption and the Town held no deed to the property. With no further discussion, the public hearing was closed with a motion from Mrs. Williams and second from Mr. Cordray.

With a motion from Mrs. Williams and second from Mr. Cordray, the August minutes were approved as written. All ayes.

General fund bills were approved with a motion from Mrs. Williams and second from Mr. Arbuckle. All ayes.

Utility fund bills were approved with a motion from Mrs. Williams and second from Mrs. Guillotte. All ayes.

Ordinance #690—An ordinance to abandon Jack Drive, a dedicated, but unopened street within the corporate limits of the Town of Logansport was adopted with a motion from Mr. Morvan and second from Mr. Arbuckle. All ayes.

The following bids were received to construct a boardwalk on the riverfront: Regional Construction, LLC--\$104,732.00; M&M Builders, Inc.-- \$113,409.50; David Lawler Construction, Inc--\$135,700.00. With a motion from Mr. Cordray and second from Mr. Morvan it was approved to accept the \$104,732 bid from Regional Construction. All ayes.

Ordinance #691—An ordinance requiring Council approval of privacy fences within the Town's corporate limits with regard to height, construction material, and color, was introduced by Mr. Cordray and second by Mr. Morvan with a public hearing scheduled for October 8, 2013 at 6:00 p.m. in the Council Chamber. All ayes.

The 2012 Audit, performed by Marsha Millican, CPA was presented to the Council for their review.

With no further business to discuss, the meeting adjourned with a motion from Mrs. Williams and second from Mr. Cordray. All ayes.
